- b) Wisconsin Open Meetings Law Review: A fact sheet from the UW Extension was provided in the packets. Attorney Meyer briefly reviewed open meetings law.
- c) Educational Opportunities for Officials: Information on the League of Wisconsin Municipalities workshops was provided. The city pays for training, lodging, meals and mileage. Most in person events are canceled due to COVID-19. Training can take place either online or with DVD's available from the clerk. Handbook order forms were distributed.
- d) Resolution 2019-02: Designating Public Depositories and Authorizing Withdrawal of City Monies: The annual resolution lists Premier Community Bank and BMO Harris Bank as our depositories and gives the Mayor, Clerk-Treasurer and Deputy Clerk-Treasurer authority to sign checks and make money transfers. m/s/c uroll Goke/Grogan to approve Resolution 2021-05 and waive the reading (designating public depositories and authorizing withdrawal of city money).
